

**Proceedings of the Election Officer for the**  
**Election of the Office Bearers of the District Basketball Association**  
**Present: Justice G.M.Akbar Ali, Former Judge,**  
**High Court of Madras**

The undersigned has been appointed as the Election Officer by the Hon'ble High Court by its order dated 01.12.2020 in C.S. No.334 of 2019, to conduct the election to the posts of Office Bearers of the District Basketball Associations (DBA) affiliated to TNBA and the posts of Office Bearers of the Tamil Nadu Basketball Association (TNBA) before 31<sup>st</sup> March, 2021. By the order dated 16.03.2021, the Hon'ble Division Bench of the Madras High Court, in O.S.A. No. 40 to 42 of 2021, extended the time to conclude the process of election by the end of July, 2021. The Hon'ble Court had also directed to decide the eligibility of the Clubs and Associations to participate in the election after affording opportunity to all parties.

By proceedings dated 07.04.2021, the list of 32 Districts and 478 registered clubs were communicated to all the District Basketball Associations and Clubs and objections were called for. A total of nine (9) objections were received from various District Basketball Associations and Clubs. After affording opportunity to all parties concerned, by a proceeding dated 23.06.2021, the list of 30 Districts and the list of 478 registered clubs as furnished by the TNBA was approved and finalised.

The election to the posts of the Office Bearers of the District Basketball Associations (DBAs) shall be conducted at the first instance and thereafter, the election for the posts of the Office Bearers of TNBA shall be conducted.

In pursuance of the power vested with the undersigned by the orders of the Hon'ble High Court, as Election Officer, the following election notification is being issued:

**1. Notification of Election to the Posts of Office Bearers of the District Basketball Association (DBA):**

- a) The election to the posts of the Office Bearers of the District Basketball Associations within the State of Tamil Nadu is hereby called for.
- b) The Office Bearers of the Clubs affiliated to TNBA shall be eligible to contest for any of the post of Office Bearers of the District Basketball Associations affiliated to TNBA within the State of Tamil Nadu. However, such office bearer of the clubs affiliated to TNBA cannot contest for more than two (2) posts of office bearers in the District Basketball Associations affiliated to TNBA.
- c) Only the President of the affiliated Clubs of TNBA or his duly authorised proxy can vote in the respective District Basketball Association election. Such proxy authorised by the President of the affiliated club of TNBA must be an office bearer in the very same club to which the President belongs and no one else can be nominated as proxy.
- d) The election shall be conducted for the following posts of office bearers of the respective DBAs:

- e) The DBAs shall be categorized zone-wise into 4 different Zones of Chennai, Coimbatore, Trichy and Madurai to cover all the 30 Districts for the purpose of election and the election shall be conducted at the following cities:

- f)** The zone-wise category of Districts is listed in **Annexure-I**.
- g)** The election schedule is listed in **Annexure-II** which contains the following:
- (i) date of nomination,
  - (ii) date of withdrawal,
  - (iii) date of Scrutiny and Finalisation,
  - (iv) release date of final list of contesting candidates,
  - (v) address and mode in which the nominations shall be accepted and scrutiny will be conducted and
  - (vi) the time, date and venue of election.
- h)** The nomination form should be filed as per proforma in **Annexure-III**.
- i)** The nominations shall be filed in person or through Registered Post or courier or by email so as to reach not later than 4 pm on the last date of receipt of nomination as notified hereunder. The venue of submission of nomination form and email id of the respective Returning officers appointed for the respective Zones are mentioned in Annexure-II. Nomination by email has to be sent to the email id of the respective Returning Officers by attaching a clear scanned copy of the duly executed nomination paper.
- j)** The withdrawal of nominations should be made as per proforma in **Annexure- IV**. Withdrawal of Nomination can also be submitted in person or through Registered Post or courier or by email. Withdrawal of nomination by email has to be sent to the email id of the respective

Returning Officers by attaching a clean scanned copy of the duly executed Annexure-IV.

- k)** Scrutiny will be done on the appointed date in the presence of the nominee or in the presence of the Agent who is authorised under Annexure – V at the venue mentioned in Annexure II.
- l)** Agent authorisation for presence at the time of scrutiny / polling / counting of votes should be as per proforma in **Annexure-V**. An Office Bearer of any Club within the same District to which the nomination has been applied for contesting for any post of office bearer in that District Basketball Association can be authorised for the purpose of this Annexure.
- m)** Proxy authorisation letter for the purpose of voting should be submitted as per proforma in **Annexure-VI** in the letter pad of the club issued by the President of the said club.
- n)** The scrutiny of nomination form, opening of Ballot Box and counting of votes shall be done in the presence of the candidate who is contesting for any of the office bearer post in the respective District Basketball Association or the duly authorised agent of the said candidate in Annexure-V.
- o)** All the annexures as above mentioned shall be made available in the tnba website – [www.tnbahub.com](http://www.tnbahub.com)

The Election Officer is hereby appointing Selvi. **Justice K.B.K.Vasuki**, Former Judge, High Court of Madras as the Returning Officer to conduct the election of DBAs for Chennai zone.

The Election Officer is hereby appointing **Mr. R. Prem Kumar, District Judge (Retd.)**, as the Assistant Returning Officer to conduct the election of DBAs for Coimbatore zone.

The Election Officer is hereby appointing **Mr. P. Deivaraj, District Judge (Retd.)**, as the Assistant Returning Officer to conduct the election of DBAs for Madurai zone.

The Election Officer is hereby appointing **Mrs. N.Uma Maheswari, District Judge (Retd.)**, as the Assistant Returning Officer to conduct the election of DBAs for Trichy zone.
